

Member Categories and Benefits

FULL GOLF MEMBERSHIP

Full Golf Membership entitles the member, spouse and dependent children under the age of 22 (if applicable) all privileges of the clubhouse, dining facilities, golf course, practice facilities and special member events. The Full Golf Membership is subject to payment of membership dues and compliance with the Fairways of Canton Golf Club Rules and Regulations.

- ✧ Family – Includes the Applicant, spouse and any children under the age of 22.
- ✧ Single – Includes the Applicant only

ASSOCIATE GOLF MEMBERSHIP

Associate Golf Membership entitles the member and spouse all privileges of the clubhouse, dining facilities, golf course, practice facilities and special member events. Golf privileges are available Monday through Friday. The member and spouse may play on the weekend with an additional surcharge of \$25.00 for each weekend round. The Associate Golf Membership is subject to payment of membership dues and compliance with the Fairways of Canton Golf Club Rules and Regulations.

SENIOR GOLF MEMBERSHIP – (55 years of age & over)

Senior Golf Membership entitles the member and spouse all privileges of the clubhouse, dining facilities, golf course, practice facilities and special member events. The Applicant and spouse will have access to the Fairways of Canton Golf Course on weekdays only. The Applicant and spouse may play on weekends with a surcharge of \$30.00 for each weekend round (\$16.00 golf car fee plus \$14.00 green fee.) The Applicant and spouse may use the Practice Facility and Clubhouse on weekends. This membership may be converted to any other plan at any time with thirty (30) days written notification to Next Generation Golf, LLC and payment of any applicable dues and/or member charges. The Senior Golf Membership is subject to payment of membership dues and compliance with the Fairways of Canton Golf Club Rules and Regulations.

JUNIOR GOLF MEMBERSHIP – (29 years of age & under)

The Junior Golf Membership includes the Applicant only. The Applicant must be under the age of 30 years old to apply. For Applicants under the age of eighteen (18), parent or guardian must provide credit card on file. At the time of the Applicant's 30th birthday, the membership will automatically be upgraded to a Full Golf Single Membership. The Applicant will have access to the Fairways of Canton Golf Course on weekdays only. The Applicant may play on weekends with an additional surcharge of \$14.00 (total of \$30.00) for each weekend round. This membership may be converted to any other plan at any time with thirty (30) days written notification to Next Generation Golf, LLC and payment of any applicable dues and/or member charges. The Junior Golf Membership is subject to payment of membership dues and compliance with the Fairways of Canton Golf Club Rules and Regulations.

CORPORATE GOLF MEMBERSHIP

The Corporate Golf Membership is owned by the corporation and is subject to payment of membership dues and compliance with the Fairways of Canton Golf Club Rules and Regulations. All participants must be employed by the corporation holding the membership. For the Corporate Golf Membership, a minimum of four (4) and a maximum of eight (12) employees are allowed. The membership entrance fee is paid with the application of the first four (4) employees. The applicable Add-On Fee is paid per additional employee, up to eight (12). The Corporate Golf Membership is subject to payment of membership dues and compliance with the Fairways of Canton Golf Club Rules and Regulations.

SOCIAL MEMBERSHIP

The Social Membership includes the Applicant and spouse. The Applicant will have access to Fairways of Canton Golf Course on weekdays only at current Guest rates. This membership may be converted to any other plan at any time with thirty (30) days written notification to Next Generation Golf, LLC and payment of any applicable dues and/or member charges. The Social Membership is subject to payment of membership dues and compliance with the Fairways of Canton Golf Club Rules and Regulations.
